7 Licence conditions

A licence will only be granted to applicants on the condition that they meet the requirements set out in Regulation 135. A summary of the conditions is included below, however, for the definitive list of conditions, refer to the Regulations www.environment.gov.au/protection/ozone/legislation

- (1) A licence granted under Subdivision 6A.2.2 is subject to the condition that the licensee:
- only carries out the types of refrigerant handling work permitted under the type of licence held, as set out in table 131 of the Regulations and on the Licensing webpage www.arctick.org/licensing/licence-types
 - carries out the work to which the licence relates in accordance with the standards set out in column 2 of the Table 135 of the Regulations. Licensees who are supervising trainee licence holders are responsible for ensuring the trainee carries out his or her work according to these standards.
 - in carrying out work to which the licence relates the licence holder must:
 - use only refillable containers for the storage of refrigerant; and
 - give any refrigerant recovered from RAC equipment to the holder of a refrigerant trading authorisation or the operator of a refrigerant destruction facility (except for recovered halon)
 - display the number allocated to the licence on any invoices, receipts and quotes for work carried out under the licence if they are not employed or hired by the holder of a refrigerant trading authorisation.
- (2) The Australian Refrigeration Council (ARC) may specify that a licence is also subject to particular conditions set out on the licence itself and in a written notice to the licence holder. The ARC may impose additional conditions on licences at any time.
